

## GUIDELINES FOR ABSTRACT SUBMISSION FOR ORAL/POSTER PRESENTATION

Please submit your abstracts under the following categories-

### A. MELIOIDOSIS

1. Case report or case series
2. Original articles

### B. EMERGING DISEASES OTHER THAN MELIOIDOSIS

1. Case report or case series
2. Original articles

**Please read the instructions carefully before submitting your abstract.**

Abstracts submitted should serve as the initial report of knowledge, experience, or best practices. Adhere to the specified word count 400 words. Use a standard typeface, Times Roman, with a font size of 12. Only .doc or .docx file formats will be accepted with a maximum file size of 4 MB. Files in any other format will be rejected. It is important to keep nonstandard abbreviations/acronyms to a minimum, to allow for readability and understanding. Briefly describe the study design, materials, and methods, thereby highlighting key techniques or approaches. Summarize the main findings and use data or statistics if relevant. Do not include tables, figures, or graphs in the abstract. Avoid unnecessary jargon or acronyms. Check for grammar, spelling, and punctuation errors. Abstract submissions will be evaluated by a review committee and the authors of the abstracts accepted for the conference shall be notified by email.

### Structure the Abstract:-

#### Title

The abstract title conveys the content/subject of the poster. The title may be written as a question or the title may be written to suggest the conclusions, if appropriate. Try to not use abbreviations or acronyms in titles.

#### Background

The introductory sentence(s) may be stated as a hypothesis, a purpose, an objective, or as current evidence for a finding.

#### Methods

Briefly describe the methods of the project to define the data and analytic techniques, as well as data collection procedures and frequencies. A description of statistical methods used may be included if appropriate.

#### Results

The results should be stated succinctly to support only the purpose, objectives, hypothesis, or conclusions.

**Conclusions**

The conclusion(s) should highlight the impact of the project and follow the methods and results logically. This section should not restate results. Rather, the utility of the results and their potential role in the management of the project should be emphasized. New information or conclusions not supported by data in the results section should be avoided.

Total word limit: Max 400

## GUIDELINES FOR POSTER PRESENTATION

Posters are to be prepared in portrait AO size (36x48 inches) and presented physically so that delegates can view posters at the conference poster booth.

### **Structure of the poster:-**

Use proper fonts for readability in Times New Roman format with title: 85-100 pt; headings: 36-44 pt and body text: 24-28 pt so that the text can be readable from 1-2 meters away.

**Title:** A concise and informative title that clearly indicates the subject of the poster with authors' names and affiliations.

The authors names and affiliation should be displayed as below –

**Keywords:** A few relevant keywords, no more than 6.

**Abstract:** The abstract should be concise, typically between 250 words, and written in an accessible manner to a broad audience, including those not specialized in the specific field. It is key to ensure clarity, coherence, and focus.

**Background:** A brief introduction to the topic, outlining the problem or research question the poster addresses.

**Methods:** A succinct description of the methodology or approach used in the research. Summarize the study design and techniques.

**Results:** The significant findings of the study are to be presented in a clear and summarized manner. Use graphs, charts, and images to present key findings.

**Conclusions:** Interpretation of the results, including their implications, significance and future directions in the context of the field.

**Acknowledgments:** Mention funding sources, collaborators, or institutions.

**References:** Include key references.

### **General instructions:-**

**Total word limit:** Max 800

**Colours:** Use a consistent colour scheme (2-3 colours max). Ensure high contrast between text and background. **Whitespace:** Avoid clutter; leave enough empty space for a clean look.

**Images and Graphs:** Use high-resolution images. Label graphs clearly (axes, units, legends).

**Presenting Your Poster:-**

All presentations and printing are the responsibility of the attendee. We do not provide services.  
Handouts / Provide a one-page summary.

## **GUIDELINES FOR ORAL PRESENTATION.**

Use the same title submitted with your abstract and the presenters name on your opening slide.

Communicate your work in an accessible way. The audience will be neurodiverse and from a variety of backgrounds e.g. research, education, practitioner etc.

Provide appropriate context to ensure an international audience can follow your paper content.

Presentations should be conducted in English.

We strongly recommend that slides are prepared in PowerPoint. Other software packages are acceptable as long as the presentation is a PDF and saved in landscape orientation and complies with the widescreen (16:9) format.

All presentations must be brought to the congress venue on a USB-key and uploaded with the technicians in the “Speaker Ready Room” in the congress venue before your presentation is due to ensure adequate time.

Please note technicians cannot upload presentations during sessions, so presenters should upload beforehand.

Please arrive in your room at least 15 minutes before your session is due to start to meet your chairperson, room manager and ensure your presentation is loaded in the room.

Oral presentations must last no more than a maximum of 7 minutes to allow for 3 minutes for questions.

Presenters must use the computer provided by the conference centre: it is not possible to present from a personal computer.

While complimentary wi-fi is available through-out the venue, we suggest that presenters should not rely on internet access during their presentation. Therefore, we recommend to embed all fonts and media within the presentation file, to not use Google Slides and do not rely on online materials, media, web pages, live demos, etc.
